



- 1 April Second Platoon, Company A received 10 rounds small arms fire from BT001612. Search was made with negative results.
- 1-8 April Third Platoon, Company B participated in OPERATION DE SOTO. Light Section, 1st Platoon, Company B occupied blocking position in support of Squad from D Company, 1st Battalion, 7th Marines, at BS718942 from 1015H to 1500H. Negative contact.
- 4 April Light Section Second Platoon, Company C escorted a convoy from 1st FAG to positions in the vicinity of NUI VO. Ontos remained in position overnight.
- 5 April Light Section, 2nd Platoon, Company C escorted a convoy from 1st FAG at NUI VO to 1st FAG CP. Negative contact.
- Heavy Section, 1st Platoon, Company C which departed on 31 March returned from OPERATION BOONE at 1900H. Negative contact.
- 8 April At 0900H Heavy Section, First Platoon, Company C supported platoon size patrol from CAC "INDIA" in vicinity of coordinates BT3310. Negative results.
- 9 April At 0930H a light section of Ontos from First Platoon, Co. B, was enroute from 1st Bn., 7th Marines CP to support a platoon sized sweep from D Co., 1st Bn., 7th Marines. At coordinates BS047988. One of the Ontos B-13 detonated a pressure-type mine which resulted in the total destruction of the Ontos. Three USMC were WIA Med-Evac. A reaction force from D Co., 1st Bn., 7th Marines supported by the other Ontos swept the area with negative results.
- 10 April At 1730 H the 2nd Platoon "Minus", Co. C departed Hill 35 (Headquarter, Fifth Marine Regiment) for the Sand Ramp to commence loading for "Operation OREGON".

Third Platoon, Company A Ontos A-32 received small arms fire from treeline at AT940600. Ontos A-32 fired 4 106mm rounds and 5 .50 caliber spotter rounds and 250 .30 caliber rounds from AT994548. No search was made due to mission.

1. Throughout the reporting period, subordinate units of this command were assigned missions as follows;

1st PLT, DS 3rd Bn First Marines

2nd PLT, DS 2nd Bn First Marines

3rd PLT, DS 1st Bn First Marines

2. 1-30 April 1967. The Ontos in DS of the 39th ARVN Bn participated in Operation CANYON 6-9 April 1967 and Operation UNION 21-25 April 1967. Company A continued to provide Ontos for escort missions, mechanized patrols, convoy escort and Defensive Positions. The terrain is excellent for Ontos operation in the First Marine TAOR.

3. 1-30 April 1967. The Ontos fired (131) 106MM rnds, (220) .50 Cal. rnds and (1,975) .30 Cal. rnds. The Ontos traveled 4,451 miles in 1,140 hours of operation.

PART II

Narrative Summary

The month of April saw a marked increase in the employment of the Ontos with infantry units. During the period 10 - 16 April the company displaced in three increments from Chu Lai to Da Nang, whereupon it resumed its role of providing direct support for the Seventh Marine Regiment. On 5 April the Third Platoon returned from "Operation Boone". (See Encl. 2)

Once the move from Chu Lai to Da Nang was completed, two platoons minus and one platoon minus were placed in direct support of 1/7 and 3/7 respectively. The First Platoon Company C accounted for 3VC KIA confirmed and 9VC KIA probable during the period 20 - 30 April. A heavy section from Company C, 3rd Anti-Tank Battalion was chopped Opcon to this command 17 April 1967 and remained in direct support of 1/26. On 27 April 1967 Ontos C-22 and C-31 were transferred to Company A, 1st Anti-Tank Battalion.

ENCLOSURE (1)

The Ontos of Company C have fired a total of sixty - six (66) rounds of 106mm during the month and have traveled a total of 1, 575 miles in support of infantry units.

Sequential Listings of Significant Events

1 April 1967. Light Section 1st Platoon Company B occupied blocking position in support of squad from D/1/7 at BS 718942 from 1015H to 1500H. Negative contact.

3 April 1967. 1st Platoon Company C fired four rounds 106mm H & I fire between the hours of 032100H to 040600H. At Coordinates BS 316159. Results unknown.

4 April 1967. Light Section 2nd Platoon Company C escorted a convoy from 1st FAG to positions in the vicinity of Nui Vo. Ontos remained in position overnight.

5 April 1967. Light Section 2nd Platoon Company C escorted convoy from 1st FAG at Nui Vo to 1st FAG CP. Negative Contact.

1st Platoon Company C fired seven rounds 106mm as H & I Fire between the hours of 042100H and 050600H to Coordinates BS 312174. Results were unknown.

Heavy Section Company C which departed on 31 March returned from Operation Boone at 1900H. Negative Contact.

9 April 1967. At 0930H a Light Section of Ontos from 1st Platoon Company B was enroute from 1/7 GP to support a Platoon sized sweep from D/1/7. At Coordinates BS 647988 one of the Ontos B-13 detonated a pressure type mine which resulted in the total destruction of the Ontos. Three USMC were WIA and med evac. A reaction force from D/1/7 supported by the other Ontos swept the area with negative results.

10 April 1967. 1st Platoon Company C fired nine rounds 106mm as H & I fire between the hours of 092130H and 100600H to Coordinates BS 323178, BS 315177, and BS 321169. Results were unknown.

14. Commanders Analysis. While it is recognized that the Ontos by its presence in a convoy discourages V. C. ambushes it must be stated that to assign it the mission of providing security for artillery positions is a complete waste of such an awesome direct fire weapons. If the Ontos must continue to provide convoy security for the artillery they should be detached once the artillery is in position and placed in direct support of an infantry unit where its shock action, and firepower could be used to its greatest advantage.

No significant mechanical failures were encountered and the Ontos proved to be completely reliable.

15. Recommendations. That in the future Ontos not be assigned the mission of providing security for artillery. The unit should not be placed in a static position but rather in direct support of an infantry unit.
