NARRATIVE SUMMARY

1. Throughout the reporting period subordinate units of this command were assigned missions as follows:

Company A, Direct Support of 1st Marines

Company B, Direct Support of 5th Marines

Company C, Direct Support of 7th Marines

2. 1-31 August 1967. The Civic Action Program for the month of August included the treating of 373 people in Yen Bac and Cam Hoa Hamlets (AT985708) and (AT975703). The old Yen Bac School House is being converted into a Hamlet meeting hall, and a new school house was built with the help of four truck loads of dunnage lumber and 100 pounds of nails. Also, 7 chicken coops are in the final stages of construction in Yen Bac Hamlet and should be completed in the coming month. On 17 August a GVN Animal Husbandry Contact Team from Quang Nam Province Headquarters (Hoi An) gave the people of Yen Bac a lecture on raising chickens. The hamlet water pump was repaired several times and Yen Bac was given 200 gallons of gasoline to run the pump. Plans are underway for purchasing chickens, holding an Elders Festival and distributing winter clothing at Yen Bac Hamlet. (U)

1-31 August 1967. The Battalion continued its mission of supporting the Southern Sector Rear Area Defense by running both day and night patrols and operations in the assigned SOR. The additional commitments of providing a rifle squad to help patrol the western flank of the Southern Sector and increasing patrol activities prior to the National Election were also accomplished. (U)

1-31 August 1967. During this time there was evidence of increased enemy activity in the Battalion SOR. On the morning of 29 August the Battalion Command Post was attacked by small arms and mortar fire in conjunction with the attack on the Song Cau Do Bridge (AT997707). (U)

1-31 August 1967, During the month of August the standdown on the Ontos mounted 106mm Recoilless Rifle was still in effect. However, permission was granted to fire the vehicle mounted 106mm Recoilless Rifle on training ranges for the purpose of maintaining combat gunnery skills and safety procedures. Also, Ontos were again employed as convoy escorts for Rough Riders. (S)

1-31 August 1967. The Battalion fired a total of 7 rounds 106mm in combat, 171 rounds of 106mm in practice range firing, 745 rounds of .50 caliber, and 7,595 rounds of .30 caliber. During the month the Battalion's Ontos traveled 4,924 miles. (U)

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS (U)

- 14 August At coordinates (BT120634) Ontos A-31 and A-33 from Company A, 3rd Platoon, received approximately 1,000 rounds heavy automatic weapons fire from coordinates (BT 120640). A-31 and A-33 returned a total of 800 rounds .30 caliber and the enemy broke contact. No search of the area was made.
- 15 August Two Ontos from Company B, 2nd Platoon, with two platoons of infantry from Company G and Company F, 5th Marines, and two LVT's, departed An Hoa (AT076473) as part of a reaction force to assist Company G which was ambushed by 100-150 Viet Cong at (AT908481). Contact had been broken by the time the reaction force had arrived. The two Ontos then set up a blocking position while Company G swept the area. The block was set at coordinates (AT909467) with negative results.
- 16 August Ontos A-33 and A-31, at coordinates (BT120635) received heavy automatic weapons fire from coordinates (BT116637). A-31 expended 150 .30 caliber rounds and A-33 returned 600 rounds .30 caliber. Search of area revealed blood trails. Results: 2 VC KIA probable.
- 21 August The Platoon Sergeant of Company A, 2nd Platoon, detonated a chicom grenade rigged as a mine at coordinates (BT011629). Results one USMC WIA MedEvac.
- 22 August At coordinates (BT016516) Ontos A-21 and A-24 (Company A, 2nd Platoon) received 30 to 40 rounds of automatic weapons fire from 10-15 VC located at coordinates (BT011541). A-21 expended 750 rounds .30 caliber and A-24 returned 1000 .30 caliber rounds. Results: 1 USMC WIA MedEvac whose status was later changed to DCW.
- 22 August A-32 and A-35 received 10 to 20 rounds small arms fire from coordinates (BT128633) while at coordinates (BT124630). A-35 expended two 106mm rounds from a ground mounted 106mm Recoilless Rifle. No search was made due to darkness.
- 26 August Ontos C-32 (Company C, 3rd Platoon) while in a defensive position at (ZC218552) fired 5 HEPT 106mm rounds at approximately 30 VC at coordinates (AT798549). An

infantry platoon from Company M, 7th Marines was ambushed, and the order to fire was given by the Infantry Company Commander. The area was searched and many blood trails and drag marks were found. Results, 5 VC KIA probable.

25 August

At 0020H a 13 man recon patrol from H&S Company was fired upon by an unknown size enemy force at coordinates (AT987702). The patrol received approximately 200 rounds small arms fire and returned 100 rounds small arms fire. The area was searched at first light and traces of blood were found. Results: 1 USMC KIA, 1 VC WIA probable.

From 0100 to 0200 two fire missions were called on the ambush site (AT987702) with unknown results.

At 0210H the Song Cau Do Bridge was attacked and at 0215H 11 rounds of 82mm mortar fire hit the 1st Antitank Battalion Command Post. At 0230H the Battalion CP received 100 rounds small arms and returned 100 rounds small arms. Results 10 USMC WIA, none MedEvac.

At 0253H 500 rounds of 7.62 M-60 Machine Gun fire was delivered at a suspected enemy position (AT986704). Area was searched at first light with negative results.

NARRATIVE SUMMARY

1. Throughout the reporting period, subordinate units of this command were assigned missions as follows:

1st PLT, DS 3rd Bn First Marines

2nd PLT, DS 2nd Bn First Marines

3rd PLT, DS 1st Bn First Marines

2. 1-31 August 1967. The Ontos were in DS of the 1st Marine Regiment. Company A continued to provide Ontos for escort missions, mechanized patrols, and defensive positions.

3. 1-31 August 1967. The Ontos fired (2) 106mm rounds, (745) .50 cal. rounds, and (5,945) .30 cal. rounds. The Ontos traveled 1,747 miles in 391 hours of operation.

PART III

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTS

- 14 August THIRD PLATOON: At coordinates 120634, A-31 and A-33 received approximately 1,000 rounds heavy automatic weapons fire from coordinates 120640. A-31 expended 400 .30 cal. rounds and A-33 expended 400 .30 cal. rounds. (See Ref (A)).
- 15 August THIRD PLATOON: At coordinates 100518, A-32 and A-35 sighted VC observer and received approximately 12 rounds small arms fire from coordinates 105521. A-35 expended 90 .50 cal. rounds. Search was not made. (See Ref (B)).
- 16 August THIRD PLATOON: At coordinates 102517, A-32 and A-35 observed with binoculars a VC approximately 600 yards away with a carbine at coordinates 105518. Received approximately 10 rounds small arms fire. A-35 expended 25 .30 cal. rounds and 20 M-16 rounds. No search was made. (See Ref (C)).

16 August THIRD PLATOON: At coordinate 120635, A-31 and A-33 received unknown amount of heavy automatic weapons fire from coordinate 116637. A-31 expended 150 .30 cal. rounds and A-33 expended 600 .30 cal. rounds. A search was conducted and blood trails were found resulting in 2 VC KIA probables. (See Ref (C)).

18 August FIRST PLATOON: At coordinate 096676, A-13 and A-14 received 50 rounds small arms fire from coordinate 093665. A-13 expended 100 .50 cal. rounds and 300 .30 cal. rounds. A-14 expended 100 .50 cal. rounds and 250 .30 cal. rounds. No search was made. (See Ref (D)).

20 August THIRD PLATOON: At coordinate 121800, A-31 and A-33 received 30 to 50 rounds small arms fire from coordinate 120630. A-31 expended 250 .30 cal. rounds and A-33 expended 250 .30 cal. rounds. No search was made. (See Ref (E)).

21 August SECOND PLATOON: At coordinate 011629, CLA2 Platoon Sergeant detonated CHICOM grenade rigged as a mine resulting in 1 USMC WIA Med-Evac. (See Ref (F)).

THIRD PLATOON: At coordinate 125630, A-32 and A-35 received 30 to 50 rounds small arms fire from coordinate 116635. A-32 expended 500 .30 cal. rounds and A-35 expended 200 .30 cal. rounds. No search was made. (See Ref (F)).

THIRD PLATOON: At coordinate 124630, A-32 and A-35 received 30 to 60 rounds small arms fire from coordinate 128633. A-35 expended 5 .50 cal. rounds. No search was made due to darkness. (See Ref (F)).

22 August SECOND PLATOON: At coordinate 975512, A-21 and A-24 received 10 rounds sniper fire from 3 VC from coordinate 046515. A-21 expended 250 .30 cal. rounds and A-24 expended 150 .30 cal. rounds. Fire ceased and sweep continued. (See Ref (G)).

SECOND PLATOON: At coordinate 016516, A-21 and A-24 received 30 to 40 rounds of heavy automatic weapons fire from 10-15 VC at coordinate 014541. A-21 expended 750 .30 cal. rounds and A-24 expended 1000 .30 cal. rounds. Action resulted in 1 USMC WIA Med-Evac, status was later changed to DOW. (See Ref (G)).

22 August FIRST PLATOON: At coordinate O27512, A-13 received 10 rounds sniper fire from coordinate O21517. A-13 expended 50 .50 cal rounds. No search was made. (See Ref (G)).

THIRD PLATOON: At coordinate L24630, A-32 and A-35 received 10 to 20 rounds small arms fire from coordinate L28633. A-35 expended 2 106mm rounds from ground mount. No search due to darkness. (See Ref (G)).

SECOND PLATOON: At coordinate 997518, A-22 received 5 rounds small arms fire from coordinate 995516. A-22 expended 350 .50 cal. rounds. No search was made. (See Ref (G)).

FIRST PLATOON: At coordinate O18515, A-13 received 10 rounds small arms fire from coordinate O16517. A-13 expended 250 .30 cal. rounds and 50 .50 cal. rounds. No search was made. (See Ref (G)).

7. Intelligence

It was suspected that enemy strength in the area numbered about three companies armed with 60 and 81 MM Mortars and small arms, a high percentage of which are automatic weapons. Upon reaching the objective area there was moderate contact with enemy forces. The terrain was rough due to dykes and dense foliage. The local population consisted of old men, women and small children. The people stayed in underground shelters or in their homes.

8. Mission

1st and 2nd Platoons, CoA, 1stATBn were in direct support and were to be used in blocking positions.

25 August 1967

9. Concept of Operation

On 21 August 1967, Ontos were to move to assembly area Dog by 1700 on D-1. They were then to move with CoK to assist in establishing Blocking Positions "X", "Y" AND "Z".

10. Execution

At 220800 H A-21 and A-24 received approximately 10 rounds sniper fire from 3 VC at 046515. At 045512 A-21 expended 250 pints and A-24 expended 150 pints. Sniper fire ceased and sweep continued. At 220940 H A-24 and A-21 at 016516 received 30 to 40 rounds of heavy automatic weapons fire from 10 to 15 VC at 014541. A-21 expended 750 pints and A-24 expended 1000 pints. Enemy fire ceased and sweep continued. At 221100 H A-13 received 10 rounds sniper fire from 021517. A-13 at 998515 returned 50 quarts. Fire ceased. At 222000 H A-22 at 017518 received 5 rounds sniper fire from 995516. A-22 expended 350 quarts. Fire ceased. At 222130 H, A-13 at 018515 received 10 rounds sniper fire from 016517. A-13 expended 250 pints and 50 quarts. Fire ceased.

11. Results

CoA(-), 1stATBn suffered 1 KIA and 1 WIA. There were no VC KIA, WIA or detainees.

12. Administrative Matters

None

13. Special Equipment and Techniques

None

14. The effectiveness of the .50 Cal. mounted Ontos was displayed for the first time to this Unit Commander. The .50 Cal. Machine Gun was an instrumental factor in suppressing heavy sniper fire from enemy positions. The Company Commander of CoK, Third Battalion, First Marines, expressed the opinion that the .50 Cal. equipped Ontos added greatly to the firepower capabilities of the force which the .50 Cal. mounted Ontos supported.

15. Recommendations

That more .50 Cal Machine Guns be procured and that measures be taken to mount all Ontos in this Command with .50 Cal. Machine Guns.

1. 031000H. Two Ontos from 2nd Platoon departed AT876473 as convoy escort to AT828383. About 031630H they returned to the CP without incident.
2. 031300H. One Ontos from 1st Platoon departed BT133446 as convoy/mine sweep escort to Hill #29 at BT232318. Estimated arrival Hill #29, 031430H. No incidents.
3. 041100H. Two Ontos from 1st Platoon accompanied platoon from Company M, Fifth Marines on a patrol 1000 meters west of BT258261. Returned to bridge at BT268273 at 041500H. No incidents.
4. 111100H. Two Ontos from 2nd Platoon departed as convoy escort to Nong Son at AT828383. Returned to Platoon CP at 111600H. No incidents.
5. 141100H. Two Ontos with security from Company F, Fifth Marines departed An Hoa as a convoy escort to Nong Son (AT828383). Returned to CP at 141600H.
