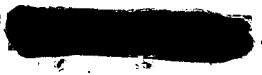

2. Commander's Narrative Summary of Significant Events

a. The 1st Antitank Battalion moved from a training status at Camp Hansen, Okinawa to counterinsurgency operations in the Chu Lai Combat Base, Republic of Vietnam during the period covered by this report.

b. On 1 March 1966, the following task organizations were re-activated, and elements of the 1st Antitank Battalion were attached to them as listed below:

(1) RLIT - 5
Company B (-), 1st Antitank Battalion (Company Headquarters only)

(2) BLT - 2/5
2nd Plt (Rein), Company B, 1st Antitank Battalion

c. The 3rd Platoon (Rein), Company B, 3rd Antitank Battalion, which had been refurbished and trained by this Battalion on Okinawa for a two month

d. The Commanding Officer, 1st Antitank Battalion and two members of this command received Letters of Commandation from the Commanding General, 1st Marine Division (Rein), for their work in the movement of Embarkation Unit Charlie from CONUS to Okinawa. Letters were received by LtCol W. MOORE, 1st Lt R.R. TIMBERG and SSgt. R.E. LINEBERRY.

e. On 15 March this Battalion conducted a test of a .50 Cal. machine gun mounted on an Ontos in place of one of the 106mm Recoilless Rifles. The test was a preliminary trial of a plan to mount two .50 Cal. machine gun's on the Ontos for direct fire support in counter guerrilla operations.

f. LtCol WALTER MOORE was designated Commanding Officer of Embarkation Group Echo for deployment of the 1st Antitank Battalion (-), 1st Motor Transport Battalion (-) Rein, and Det, H&S Company (-), 3rd Amphibious Tractor Battalion, to RVN.

g. H&S Company, 1st Antitank Battalion embarked aboard the USS WHETSTONE (LSD-27) on 22 March. Major J.J. KEEFFE, S-4, 1st Antitank Battalion, was Embarkation Team Commander.

h. H&S Company arrived in RVN on 27 March. A temporary CP was established with the 11th Marines while a permanent CP for the organizations were being constructed farther forward in the TAOR.

i. Company C, 1st Antitank Battalion reverted to parent unit control upon this Battalion's arrival in RVN. This Battalion also assumed administrative and operational control of 1st and 2nd platoons, Company B, 3rd Antitank Battalion.

j. Company A (-), 1st Antitank Battalion deployed from Okinawa on 31 March aboard the USS WINSTON (AKA-94). Capt G.R. VAN HORN, Commanding Officer, Company A, was Embarkation Team Commander.

3. Detailed Description of Significant Events.

a. Testing of .50 Caliber Machine Gun Mounted on Ontos.

Operational reports from Marine forces in the Republic of Vietnam have indicated the desirability of a light tracked vehicle for use in direct fire support of infantry. The Ontos has proven its ability to negotiate terrain which is not accessible to tanks or wheeled vehicles, however its main armament is designed for antitank use. The backblast, relatively low ammunition capacity, and burst characteristics of the 106mm recoilless rifles have inhibited its effectiveness as a counter guerrilla weapon.

It was theorized that the replacement of two of the six 106mm rifles on the Ontos with .50 Caliber coaxially mounted machine guns would increase its flexibility as a fire support weapon, and permit rapid ambush and counter ambush fire in situations where the smaller caliber round would be more appropriate, or where the firing of the 106mm weapon would be precluded due to friendly troops or equipment in the backblast area.

The theory was tested on 15 March 1966 at the Camp Hansen, Okinawa firing range. Using a locally fabricated mount, one caliber .50 caliber machine gun was fired in place of the number 4 rifle on the Ontos. (See pictures 1, 2 and 3) As with the 106mm recoilless rifle, the weapon was charged manually from outside the vehicle. It was fed from a 200 round ready box. Target acquisition, aiming and firing were accomplished from within the vehicle, using the Ontos fire control system.

The test showed that the emplacement of .50 caliber machine guns can be done without modification to the Ontos, that room is available for belts of up to 600 rounds per machine gun, and that well aimed .50 caliber fire can be delivered in this manner.

On 28 March 1966, this battalion requested sufficient M85 machine guns to arm thirty (30) Ontos as described above.

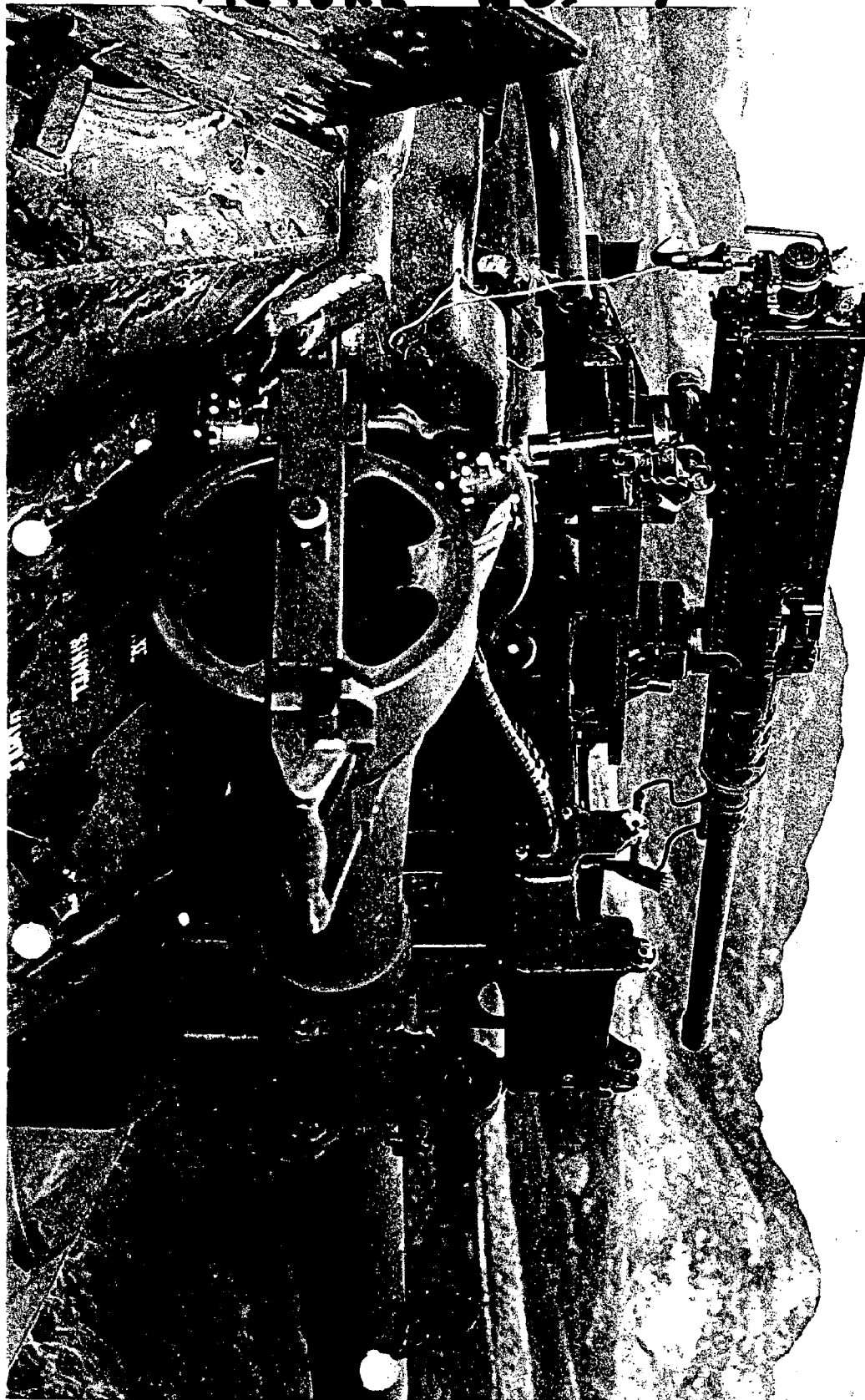

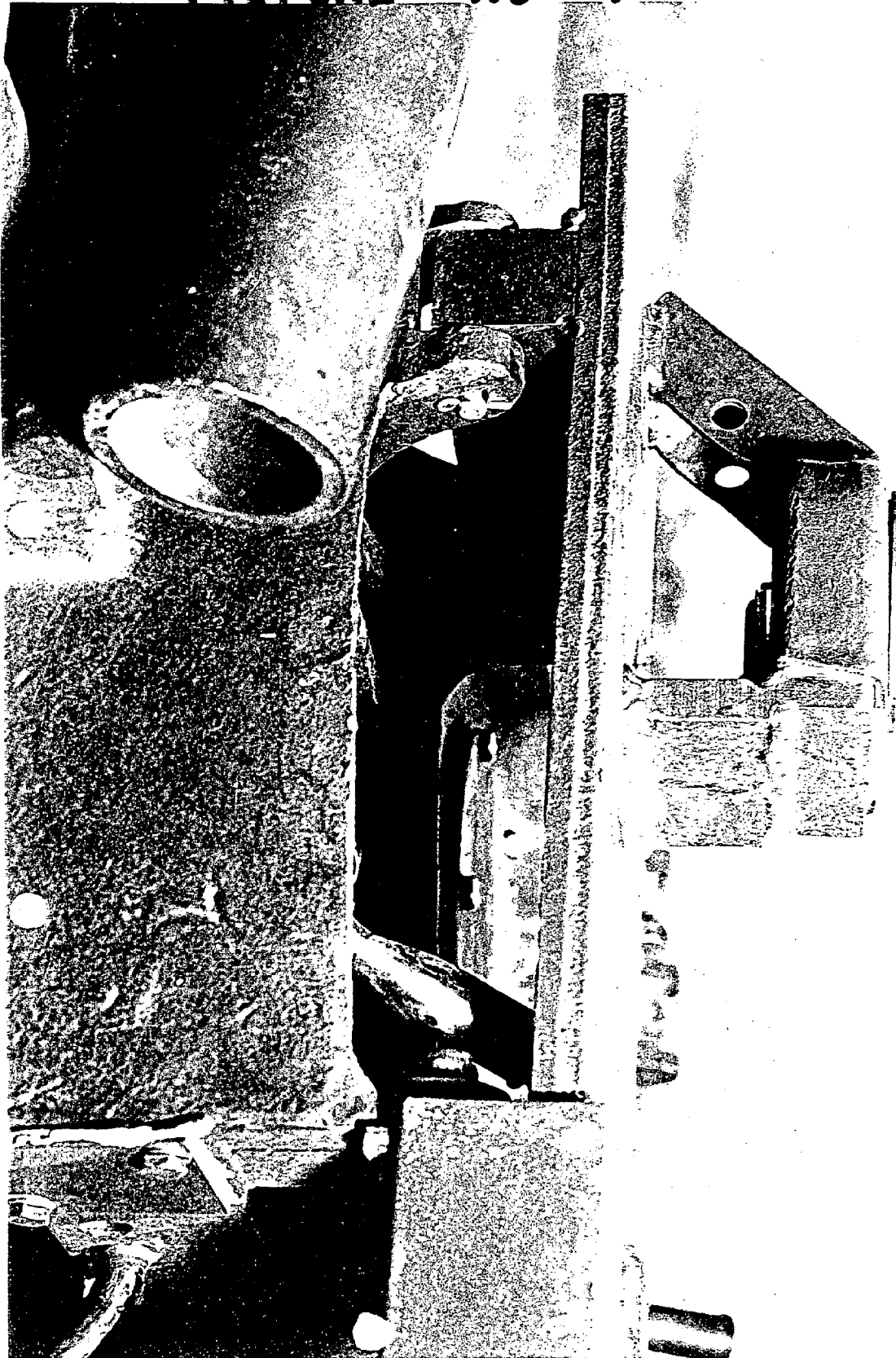

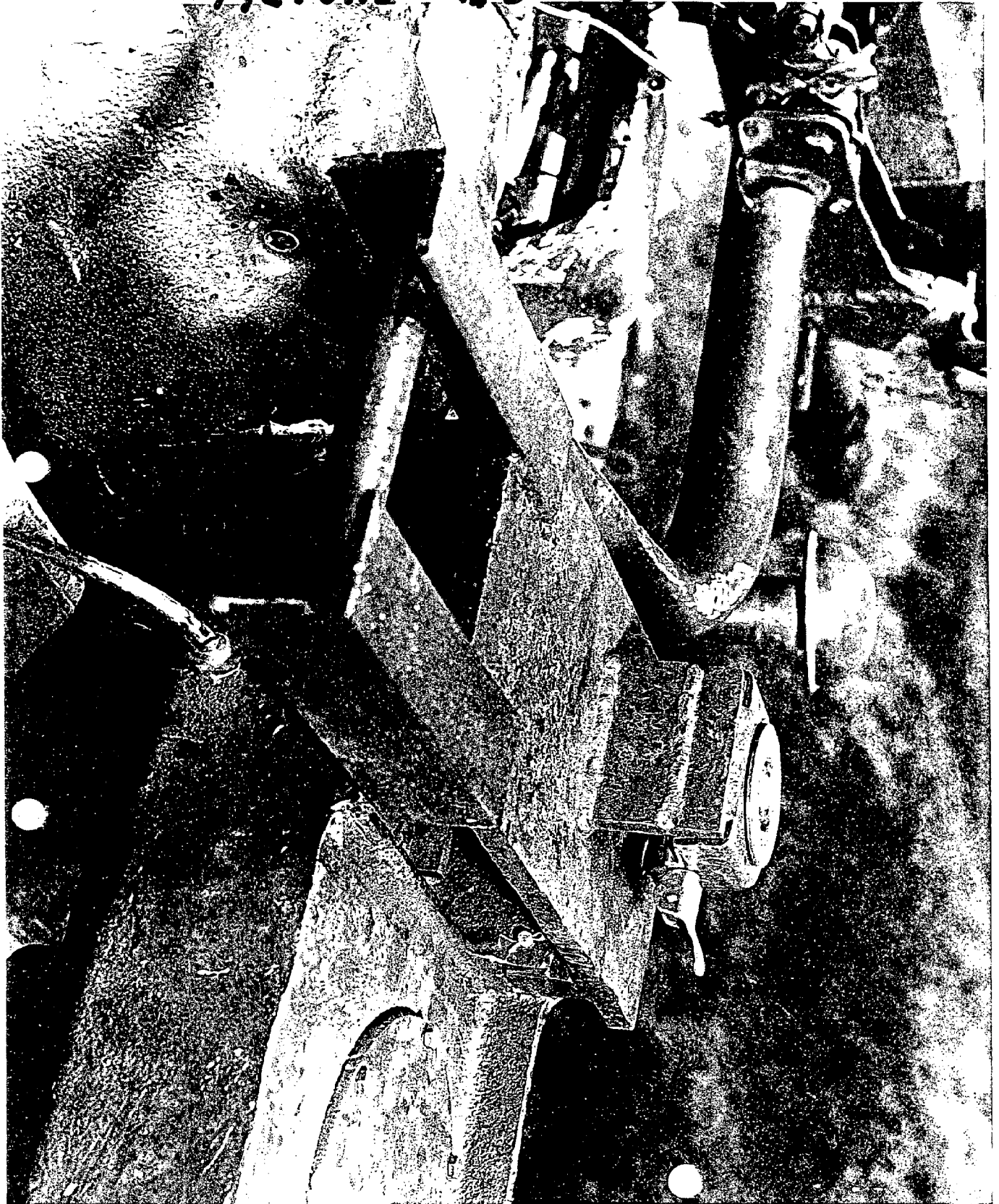

1 March 1966 Attached to Regimental Landing Team 5 with administrative control resting in 5th Marines. Strength upon joining was 2 USMC Officers, 45 USMC Enlisted, and 1 USN Enlisted. Task organization included the 2d Platoon.

1 - 24 March 1966 2d Platoon conducted intensive training to include 106mmRR FIREX, field exercises, Jungle Lane firing, Counterguerrilla Warfare School, FAM Firing of individual weapons and crew served machine guns, Land Mine Warfare/Demolitions/Booby Trap School, and combat driving with the M-50A1 ONTOS.

2. Operations

The convoy arrived at their destination and picked up the troops from 2/7 which had just completed Operation "Utah". The convoy returned to the Chu Lai enclave at 1915 on 7 Mar 1966.

The fifth ontos remains in the platoon CP at (BT509028). Two men are used on a walking security post around the platoon C.P.

c. The third platoon in support of 3/7 has been manning positions on the MLR. A light section is located at (BS549996) in support of M-3/7. Another light section is located at (BT529002) in support of I-3/7. The fifth ontos is at the Company CP deadlined for lack of track. On 7 March 1966, a light section escorted a twenty-five truck convoy south on Highway #1 to (BS637784) and picked up troops from 2/4 that had completed Operation "Utah". The convoy left the Chu Lai enclave at 1430 and returned at 1800 the same day. Since the return of the convoy the 3rd platoon has only one Ontos at (BS549996).

d. Company Headquarters continues to man two (2) M-60 MG positions at (BT560048) in conjunction with the 7th Marines Beach Security Plan.

2. Operations.

a. The first platoon in support of 1/7 has been manning positions on the MLR. The light section was in support of B-1/7 at (BT605995) and the heavy section was in support of C-1/7 at (BS588981). On 17 March, from 0500-1600, a light section supported 3/7 on Operation "West Virginia" in the area of (BS5489). c. The third platoon in support of 3/7 has been manning one position with one ontos at (BS549996). During the period 11-14 March a light section was in support of 3/7 while conducting Operation "C&H" in the area of (BS593934). The objective of the operation was to provide security for the 1500-2000 ^{workers} while they harvested the sugar cane in the area. The mission of the ontos section was two-fold; (1) to provide direct fire support for the Battalion as part of a reaction force (2) to provide security and a show of force for the Vietnamese laborers. On 16 March the platoon displaced its' CP from (BT560048) to (BT547016).

d. Company Headquarters displaced its' CP from (BT560048) to (BT547016). The move commenced on the morning of 16 March and was completed on the afternoon of 19 March. During this period personnel provided beach security and security at the new CP site.

3. Training.

a. Classes were conducted in the following area's: Target engagement and adjustment of fire, misfire procedures, ammunition safety precautions and indirect firing procedures. Inspections were held on OEN gear, personal weapons, Comm gear, and personnel. During the two day firing exercise, both the direct and indirect methods of firing the Ontos were employed. 503 rounds of 106MM, 330 rounds of .50 Cal. spotter, and 340 rounds of .30 Cal. was expended.
