a. Mines. During the month of August 1967, there were 17 mine incidents. 12 required organizational maintenance repair and 4 required field maintenance repair. 1 tank was coded out as combat loss. The mined vehicles were under repair for an average of 9 days, the longest being 28 days and the shortest being 4 days. 4 tanks are as yet unrepairod. Personnel casualties from AT mines was 15 WIA non-evac.

b. Recoilless Rifle. During the month of August there were no recoilless rifle incidents.

c. AP Mines. 1 AP mine was detonated by tanks in August.

III. Southern Defense Sector.

a. The combat operations center of the 1st Tank Battalion continued to initiate, control and coordinate defensive activities within the Southern Sector. 862 tenant unit activities were conducted. 1st Tank Battalion conducted 62 patrols and ambushes and responded with 16 special activities ranging from squad to company size when intelligence or the circumstances warranted.

b. A total of 9 detainees were captured during August. There were 3 VC KIA Probable. 2 caves were destroyed and one homemade VC mine was captured and destroyed.

c. 5 significant events occurred in the Southern Sector during August. At 160215H an 8 man ambush patrol from H&S Company, 1st Tank Battalion at AT969699, observed a man in the water with an object in his hand. The ambush opened fire on the man with small arms and grenades and observed the man fall underwater indicating one VC KIA probable. At 232005H an H&S Company, 1st Tank Battalion OP at AT965704 observed a 15' boat proceeding downstream. A four man patrol was dispatched to check the boat when it stopped on the opposite bank. The patrol checked the boat and scuttled it with a hand grenade. As the patrol was returning from the boat, it received 20 to 30 rounds S/A from the opposite bank. The patrol returned to the OP and kept the boat under observation. At 232130H the boat began to move again. The tank at the OP destroyed the boat with one round HE. There was one friendly WIA non-evac. At 270230H a squad sized patrol from H&S Company, 1st Tank Battalion walked into an enemy ambush at AT952705. The patrol returned fire with S/A fire and grenades. A search was conducted at first light which found AK-47 shell casings and pools of blood indicating 1 VC KIA probable. At 290020H an H&S Company, 1st Anti-Tank Battalion 12 man patrol was

ambushed by an unknown number of enemy at AT986702. The patrol returned small arms fire and withdrew. An artillery mission was called in with unknown results. A sweep of the area at first light revealed AK-47 shells and shell casings. There was one friendly KIA sustained during the action. At 290215H the bridge at AT998705 and the 1st ATBn CP at AT989710 were mortared from AT985702 and AT985698, and the bridge was blown with satchel charges. Approximately 10 rounds of 82mm mortar fell on the 1st ATBn CP. An artillery mission was called on the mortar sites. 1st ATBn had 10 WIA non-evac.

IV. Training

a. For the month of August centered on the new family of radios currently being installed in the tanks. Training was conducted on the company and platoon level. Continued emphasis was placed on weapons safety and M16A1 training in all companies. A total of 470 man-hours of training was conducted within the Battalion, ranging from 136 man-hours in H&S and B Companies to 94 hours in A Company.

b. Officers and Staff Noncommissioned Officer training consisted of a voluntary weekly briefing. During this period personnel attending were kept appraised of current operational and intelligence matters. Several mandatory meetings were called during which various defensive proceedings within the battalion were discussed and reviewed.

V. Ground Based Defoliant Report

a. During the month of August 1967 flame tanks expended a total of 720 gallons of napalm mix in execution of assigned fire missions.

~~SECRET~~C. SIGNIFICANT OPERATIONS CONDUCTED

1. At 011530H, a section of tanks from the 1st platoon, Company B, located at AT975595 on patrol with infantry received approximately 150 rounds small arms fire and 1 rocket which was believed to be an RPG-2 from AT978595. The rocket hit approximately 15 meters to the front of the tank. The tank returned fire with 11 rounds 90mm canister, 200 rounds 50 cal. and 400 rounds 30 cal. with inconclusive results. 1 tanker was WIA, med-evac.
2. At 020050H, a tank from the headquarters section, Company C, while in support of the infantry at BT099617, detonated a mine. The tank was moderately damaged.
3. At 020645H, a tank from the 2nd platoon, Company C, detonated a mine at BT105615. The mine was approximately 50 lbs of TNT. The tank was heavily damaged on the right side.
4. At 022150H, a tank from the 1st platoon, Company C, located at BT205515 received sniper fire from the tree line at BT205516. The tank fired approximately 100 rounds 50 cal. A search of the area revealed 2 VC KIA confirmed.
5. At 031330H, a tank from the 2nd platoon, Company C, located at BT200469, spotted 1 VC at BT200479. The tank fired 3 rounds 90mm HE and 100 rounds 50 cal. A sweep force searched the area and found 1 pair of black pajamas with blood and 1 rifle of unknown type indicating 1 VC KIA probable.
6. At 042315H, a tank from 1st platoon, Company C, on patrol with infantry, detonated a mine at BT078698. The tank was moderately damaged on the left side.
7. At 050215H, a tank from headquarters section, Company B, located at AT960606 as security for bridge, received one hand grenade while the bridge was under attack resulting in one tank crewman WIA non-evac.
8. At 051520H, a tank from the 3rd platoon, Company C, located at BT015576 while in support of infantry, was requested to fire upon a house at BT013570 from which sniper fire was being received. The tank fired its 90mm. One VC was observed to take a direct hit. There was one VC KIA probable.
9. At 051900H, a tank from the 1st platoon, Company B, located at AT077575, was requested by infantry to fire upon a suspected VC warehouse and boat on the river at AT082555. The tank fired 16 rounds 90mm HE and 1 round 90mm W. The warehouse and boat were destroyed with two secondary explosions in the warehouse. There were 4 VC KIA confirmed.
10. At 061340H, while waiting for the platoon commander to find a route, the crew of a 3rd platoon, Company A, tank, searched a church at BT007357.

The crew found M79 rounds, 5.56 rounds, 7.62 rounds, an M-16 magazine and documents hidden behind the altar. The items were given to the infantry.

11. At 061900H, a tank from the 1st platoon, Company B, located at AT878557, was requested by infantry to fire upon a suspected VC position located at AT87554. Upon observation, 5 VC were spotted in the treeline. The tank fired 90mm HE with direct hits and a secondary explosion. There were 5 VC KIA probable.
12. At 071030H, a tank from the 1st platoon, Company B, located at AT877578, was requested by infantry to fire upon a treeline and a house at AT992554 and AT887559. The tank fired 90mm HE and 50 cal. and destroyed the house.
13. At 081330H, a tank from the 1st platoon, Company B, located at AT977576, was requested by infantry to fire upon activity in a treeline located at AT876551 and at VC moving through a rice paddy at AT872546. The tank fired 90mm HE resulting in 1 VC KIA confirmed and 5 VC KIA probable.
14. At 091030H, a tank from the 1st platoon, Company B, located at AT877577, was requested by the infantry to fire upon a boat taking supplies across the river at AT883554. The tank fired 8 rounds 90mm HE, resulting in 5 VC KIA confirmed and 1 VC KIA probable.
15. At 091200H, a tank from 2nd platoon, Company A, hit a mine of approximately 30 lbs at AT913495. There was moderate damage to the tank, but no casualties.
16. At 111300H, a tank from the 1st platoon, Company B, detonated a mine at AT825555 while in convoy, resulting in 3 WIA non-evac.
17. At 111300H, a tank from the 1st platoon, detonated a mine of approximately 40 pounds at AT842562. There was one WIA non-evac.
18. At 120800H, a platoon blocking force from H&S Company, participated in a combined sweeping operation at Phu Hoa, AT955705, Cam Hoa (1), AT965705, and Cam Hoa (2) at AT975703 with ARVN forces from Hoa Cam Training Center.
19. At 121335H, a tank from the 2nd platoon, Company C, detonated a mine at AT107593, sustaining moderate damage. There were two WIA non-evac.
20. At 131900H, a tank crew from the 1st platoon, Company B, located at AT984602, observed 6 VC moving west at AT889551. The tank crew fired 90mm resulting in 2 VC KIA confirmed and 1 VC KIA probable.
21. At 132000H, 2 tanks from the 3rd platoon, Company C, located at BT005585, were requested by infantry to support the med-evac of a

pinned-down patrol. After receiving S/A fire from BT006508 they fired 90mm and 30 cal. No search was made due to the nature of the med-evac.

22. At 141400H, 3 tanks from the 1st platoon, Company A, located at BT106477, received automatic rifle fire from a village at BT107477. The tanks returned fire with their 90mm guns at various parties of VC fleeing into the hills. No search was made due to the mission of the unit, but there were 18 VC KIA probable.

23. At 160215H a squad (-) sized patrol from H&S Company, located at AT 969699, observed a man in the water with an object in his hand at AT969569. They fired S/A and threw 2 grenades. They observed the suspect fall back in the water when he was hit. The suspect never reappeared indicating one VC KIA probable.

24. At 170745H, a tank from the 2nd platoon, Company B, located at AT985635, was on an engineer team security sweep when it was struck by 2 command-detonated claymore mines. The mines had been placed approximately 30 feet off the road. There were 2 USMC WIA, 1 med-evac.

25. At 180090H, an 8 man ambush patrol from H&S Company, located at AT970699, observed an object floating on the river at AT969699 which was moving to fast for the current. The patrol called for tank illumination and fired 2 rounds M-79 and 20 rounds S/A into the unknown object. They sank the object. Results are unknown.

26. At 181900H, a tank from the 2nd platoon, Company B, located at 875575, observed 2 VC in a rice paddy at AT087545. It fired 90mm resulting in 1 VC KIA confirmed and 1 VC KIA probable.

27. At 190500H, an H&S Company platoon blocking force participated in a combined sweeping operation at Phong Bao (1), Yen Bao (1), Cam Hoa (1) and Cam Hoa (2) with ARVN forces from Hoa Cam Training Center. The 18 detainees who were picked up on the sweep were forwarded to Hoa Cam Training Center.

28. At 201150H, a tank from 3rd platoon, Company A, located at BT023342, fired at a confirmed enemy position at BT018327. There were 3 VC KIA probable.

29. At 201440H, a tank from the 1st platoon, Company C, detonated a mine of approximately 60 lbs. at AT904584. There were no casualties and only moderate damage to the vehicle.

30. At 211245H, 2 tanks from the 1st platoon, Company A, spotted 12 VC in an open field at BT000465. Some wore black pajamas and some wore uniforms and several appeared to be carrying weapons. The tanks fired 50 cal. and 90mm resulting in 8 VC KIA probable.

31. At 210930H, a tank from the 1st platoon, Company C, observed Vietnamese children acting suspiciously while playing in the road at BT066665. Investigation and digging disclosed a booby-trapped mine, which was blown in place, leaving a 2½ ft. by 4 ft. crater. The children fled.
32. At 212345H, a tank from the 2nd platoon, Company C, detonated a mine at BT100612. There were no casualties and only moderate damage to the vehicle.
33. At 211845H, a tank from the headquarters section of Company C, detonated a mine at BT040652 causing extensive damage to the vehicle, but no casualties.
34. At 222100H, a tank from the 3rd platoon, Company A, fired H&I fires at a suspected enemy mortar position. There was one secondary explosion.
35. At 231030H, a tank from the 2nd platoon, Company B, located at AT877574, observed several VC unloading a supply boat at AT850552. The tank fired its 90mm gun resulting in one destroyed boat and 2 VC KIA confirmed.
36. At 240715H, a tank from the headquarters section of Company C, detonated a mine at BT068628 while participating in a tank-infantry sweep. There was light damage to the vehicle and one USMC was WIA non-evac.
37. At 241530H, a tank from the 2nd platoon, Company B, located at AT876576, observed VC in a rice paddy at AT862551. The tank fired its 90mm gun resulting in one VC KIA probable.
38. At 251715H, a tank from the 3rd platoon, Company A, detonated a mine at AT995354. There was one crewman WIA med-evac and 3 crewmen WIA non-evac.
39. At 250847H, a tank from the 3rd platoon, Company A, spotted 2 VC with weapons and carrying packs at AT974345. The tank fired its 90mm gun resulting in 2 VC KIA confirmed.
40. At 271745H, a tank from the 2nd platoon, Company C, detonated a mine at BT098617 while on patrol with infantry. There was extensive damage to the vehicle, but no casualties.
41. At 280400H, a tank from the 2nd platoon, Company C, detonated a mine at BT089609 while transporting troops to a blocking position around an enemy rocket site. There was light damage to the vehicle and one tank crewman was WIA non-evac.
42. At 281845H, a tank from the 2nd platoon, Company B, located at AT926527, observed 4 VC moving into a village at AT935512. The tank fired its 90mm gun with a direct hit on one VC resulting in one VC KIA probable.

43. At 281845H, a tank from 2nd platoon, Company A, spotted 4 VC moving into a village at AT935512. They were carrying packs. The tank fired its 90mm gun and one VC was seen blown 6-8 ft. in the air. There was one VC KIA probable.

D. CASUALTIES SUSTAINED

During the month of August this battalion sustained 22 casualties, 4 of which were medically evacuated.

During the same period there were 3 Marines medically evacuated for non-battle reasons.

SECRETE. CIVIC ACTION

On 10 August, the chairman of the Farmers Cooperative came by the CA office and presented the CAO with the minutes of a meeting of the Co-op. At the present time there are 42 people who have bought shares in the Co-op. The total capital collected is 37,500 \$VN. A four man contingent from the Co-op has visited the Province Agriculture Office for the purpose of discussing planting sweet potatoes and Guatemalan seed corn for feed. A meeting was also held to discuss formal organization of the Co-op.

On 11 August, the hamlet chief, Mr. Duong, came to the CA office with a letter requesting that the CAO close the Market Place. The local officials felt that the Market Place, because of the number of people concentrated there, would be a probable target for VC terrorism. There has been intelligence regarding VC that have been circulating in the Market Place and attempting to collect taxes from the merchants. The CAO went to the Market Place and removed all "on limits" signs, explaining to the merchants why the action was taken.

On 16 August, the CAO conducted a survey of all sand recovery operations on the Song Cau Do River. The survey was conducted in an effort to determine what effect closing the river would have on the people making their living retrieving and selling sand. The conclusions drawn from the survey indicated that there were at least 300 people making their living this way and that many of them were refugee families from Viet Cong controlled areas. The closing of the river to these sand recovery boats would create an extreme hardship on most of these people as they have no resources other than their boats.

On 30 August, the CAO conducted a survey of rice producing areas in the Southern Sector. The purpose of the survey was to determine what steps would have to be taken to insure that rice harvested from the sector doesn't fall into VC hands. The relative close distance between the harvesting points and collection points will require only limited security and can easily be enforced by primarily using PF's.

During the month of August, the MEDCAP figures remained high despite the missing of 2 MEDCAPS due to lack of security. The MEDCAP team treated 98 people at the 1st Tank B.A.S., 312 at Cam Hoa, 332 at the Hoa Cam Dependents Area and 840 at Phong Bao, a total of 1582. During the month the CA Team distributed the following materials.

1. 100 bags of cement, 2,800 gallons of water, one truck load of lumber, 50 pounds of nails, 1 1/2 truck loads of gravel, 2 truck loads of sand and 9 truck loads of fill-in dirt to the Buddhist School at the Four Corners.
2. 80 bars of soap at MEDCAP.
3. Seven loads of scrap lumber to people in the hamlet to be used as firewood.

4. 26,000 pounds of garbage to the pig Breeding Farm and individual farms.

During the month of August the FYSOP movies at the outdoor theater was cancelled due to the increased threat of VC terrorist acts during the national elections. Two films were shown on the first two Monday nights of the month and drew an attendance of 1,350.

Construction of the Buddhist School at the Four Corners continues at a rapid pace. At the end of the month the tile roof had been put up and about one-half of the walls have been stuccoed. Completion target date is 10 September.

During the month of August, the dispensary at the Market Place was begun. One of the existing stalls is being converted into a dispensary. Considerable work remains to be done due to the fact that the floor which was poured over a year ago needs to be repaired. The completion target date is 30 September. Upon completion of the building, it will be staffed by two Vietnamese nurses in the afternoon. Hygiene classes are scheduled to be conducted twice weekly at the dispensary.

During the month of August, there were six cases of strategic material being turned into the CA Team by persons living in the hamlet. The net results for the month include three M-26 grenades, one compass, 16 rounds of M-16 ammunition with magazine and 8 rounds of .45 cal. ammunition with magazine. There was one occasion when a grenade was turned in and the man refused a reward saying that he was repaying the Marines for the work they have done in the hamlet.

Psychological operations continue to be intensified in the sector. The rewards program has already shown some results for the increased efforts in this area. There has been some VC mine activity in the western sector of the TACR and as a result, leaflets dealing with rewards for turn-in or information about mines will be stepped up. The bridge spanning the Song Cau Do River at the Highway 1A crossing was destroyed on August 28 by a VC Sapper unit. The VC crossed the river at Yen Bac and attacked the bridge security platoon from Phong Bac. As far as can be determined there were no backlash incidents arising out of the counter mortar fires called in by Marine units.

All companies are within the DaNang Tactical Area of Responsibility, except Company A (-) (Rein) which is located in the 5th Marines operational area. The 1st Tank Battalion retains administrative control of all companies.

The 1st Tank Battalion is currently in personnel category C-1 with a chargeable strength of 40 Marine Officers, 681 Enlisted, 1 Navy Officer, and 14 Navy Enlisted.

During the month of August, the battalion joined 9 Marine Officers and 23 Marine Enlisted. 3 Marine Officers and 56 Marine Enlisted were transferred.

SECRETH. INTELLIGENCE

Incidents. Incidents involving 1st Tank Battalion this month accounted for 19 VC KIA confirmed and 47 VC KIA probable. These figures are up considerably from last month indicating both improved employment of tanks and increased activity of the VC in the Danang area.

Mines. There were 17 mine incidents this month which indicates increased guerrilla activity within the Danang TACR. One incident involved a tank being hit by 2 claymore mines placed at the side of the road and command detonated. Other mines were the usual box-type varying in size from 20 to 100 lbs. Of these, 2 were electrically detonated, 1 was command detonated, and the rest were pressure detonated. The 1st mine in the 5th Marines area of responsibility was hit this month. Documents captured in the 3/1 area revealed the first positive information on the methods used by the VC for obtaining and emplacing mines.

Intelligence Information. The amount of intelligence information received increased over last month. Many reports were received particularly during the last half of the month because of the increased VC activity before the national elections in September. On 16 August two females were apprehended and found to be carrying 7 VC documents some of which were marked Top Secret. Interrogation of these women also led to the apprehension of several other VC sympathizers.

SECRETI. LOGISTICS.

1. Supply Situation. Supply response has been rather slow during the past month. This is particularly true in response to common type items such as stencils, toilet tissue, mimeograph paper and duplicating paper to list a few. These items have been on requisition for a period of 5 months or longer with little or no supply response. This command was able to obtain the above mentioned items on a Priority O2 walk-thru requisition. Repair parts for the crack vehicle suspension systems remains slow and inadequate. Two M-5 Compressors and two M-54 radiators were received during the month to help alleviate the critical status on these items. With receipt of the Xenon lights, the requirement for 18" searchlight bulbs no longer exists. No problem areas are foreseen at this time for Class I, III, and V supplies.

3. Significant Problem Areas. Blank forms are still in short supply. There is no change in the supply of left hand torsion bars. Some 782 gear has been received.

4. Maintenance Situation. The general status of maintenance during this period has been good except for the problems listed in paragraph 7. Significant renovation of the huts within the cantonment has been accomplished in preparation for the monsoons. Additional drainage ditches have been added and a large culvert was recently installed under the main entrance road.

6. Significant Maintenance Problem Areas. During this period a total of 15 tanks sustained mine damage. This is 6 more tanks than last month. The slow supply response on spare parts to repair these tanks has necessitated selective interchange of certain parts with vehicles to be evacuated from in-country. The selective interchange process requires over twice the labor time normally expected to accomplish any given repair. The mine incidents also contribute, either directly or indirectly in some cases, to engine and transmission damage. Currently 11 tanks are in 3d echelon maintenance for repairs.
