

PERSONNEL AND ADMINISTRATION

Present officer strength is 34 compared to an authorized strength of 40. Enlisted strength is 552 compared to M/L strength of 636. Approximately 97 enlisted will be rotated during January and February.

The Battalion joined no officers and 111 enlisted during December. Losses were 3 officers and 104 enlisted.

Six requests for extension overseas were forwarded during December. The extensions bring the total man-months gain through extensions since 1 January 1967 to 6... The major factors in the favorable rate of extensions are the special 30 day leave and the R&R program.

Morale remains exceptionally high within the battalien. Personnel continue to use the improved post exchange resources and the new laundry facilities which are contributing factors.

One summary courts-martial was held during December. There were fourteen instances of punishment under article 15, UCMJ in the battalian.

On 15 December 1967 5 officers and 111 enlisted were attached to this command from Company "A" 3d Anti-Tank Battalion. The attached Anti-Tank Company is on company administration while this Battalion is on battalion level administration.

Battalion level administration continued to present no major problem.



INTELLIGENCE

Weather. Temperatures during December fell within the mean high (75°) and low (65°). Precipitation was 18.41 inches as compared to the December monthly average of 14.6 inches.

Rainfall throughout I Corps during December was moderate to heavy. Precipitation was recorded on 2J days during the month. This coincides with the December mean. Precipitation had the net effect of continuing to curtail tank movement due to reduced trafficability. Tank operations were again limited to convoy security.

Intelligence. Artillery and mortar attacks on the outposts of Con Thian and Gio Linh were loss frequent then in the past. The enemy has apparently snifted his attention for the present to the new A-3 position. This position was hit frequently during December. Dong Ha and Camps Evans and Carroll were not attacked.

During December the enomy continued infiltration of troops south. The Hue City Sapper Battalien, an NVA unit, was confirmed as operating in the vicinity of (YD 7404). Its strength is reported at 225 men. Until December this unit was carried on the OCB as "possible".

During Docember a number of reports were received of enemy units massing in the Quang Tri area for a push on Quang Tri City. Reports indicated the attacks would come between Christmas and Tet. By the end of December the attack had not materialized.

On 14 Docember a patrol from H&S Co. 3d Tank Entiation at Gia Lo Combat Base picked up 1 vN male as a vC suspect. The suspect had no ID card though he claimed residence in the area for 6 years and was of 1 gal age. The suspect was released as an innocent civilian. On 20 December encode patrol from H&S Co. 3d Tank Battalien hade contact with an unspecte mass. of vC. Results of the contact were 2 vC mIa(f), 1v0 WIA fOW, an AK-47 with 2 magazines, NVA 762 gear, 2 Chicam procedus and documents. The POW died of wounds defere he could be interrogated. Through the documents in his possession the vC as identified as Nguyon Duy Hiow. He was a VC squad leader from They Phuong. Other documents showed his unit had been active in mining Highway #1 between Phu Bai and Hue. Also it was discovered that he had taken part in the attack on CAC/A69 in her mbor.

OPERATIONS AND TRAINING

During the month of December tanks of this Battalion participated in five operations. Poor trafficability continued to restrict tank activity and the majority of the Battalion's effort involved firing from static positions.

Operation Kentucky. Tanks of "A" Company and one platoon of "A" Company, 3d AT Battalion supported the 1st Battalion, 1st Marine Regiment, 3d Battalion, 4th Marine Regiment, 12th Provisional Artillery Battalion, and the 2nd Battalion, 1st Marine Regiment in the Cam Lo, Con Thien, 3io Linh area. Support rendered included counter battery and the 1fires, firing cannister at suspected enemy infiltration routes and direct HE and WP fires against enemy bunkers. In addition tanks at Con Thien accounted for eleven KIA(C) and twenty-one KIA(P) on 15 December while operating with elements of 1st Battalion, 1st Marine Regiment. The tanks fired beshive and cannister. On 15 December tanks at Gio Linh accounted for five KIA(C) and 5 KIA(P) by firing an observed mission.

Operation Lancaster. Tanks of "B" Company participated in the operation in the Camp Carroll - Rockpile areas. The Company supported the 3d Battalion, 9th Marine Regiment. Support included providing security for sixteen convoys to the Ca Lu position. During these convoys the tanks fired HE, cannister, machine guns and flame at suspected ambush sites. On 19 December one tank on the convoy took an RPG hit during an ambush. The hit resulted in one WIA (med-evac). On 28 December the unit sustained one WIA (med-evac) from sniper fire along the route to Ca Lu. In addition to the convoy escort the tanks fired 90mm at suspected enemy gun positions and H&I fires.

Operation Scotland. Tanks of the 3d Platoon of Company "5" and Company "A" 3d Anti-Tank Battalion supported units of the 26th Marine Regiment during this operation in the Khe Sanh area. Support was limited to participation in one patrol during which ten rounds of 90mm HE were fired at suspected enemy anti-aircraft positions.

Operation Noosho. Tanks of Company "C" participated in this operation in the Phong Dien area. The unit supported was the 1st Battalien, 9th Marine Regiment. Tanks fired 90mm HE H&I fires around Camp Evans, and one plateon went on patrol with "A" Company, 1st Battalien, 9th Marine Regiment with negative results.

Operation Napoleon. On 21 December two tanks from "C" Company were moved to the Cua Viet area and placed in direct support of the 1st amphibian Tractor Battalion. To date these tanks have participated in two patrols with negative results.

On 3 December one platoon of Company "C" was chopped to Battalion Landing Team 2/4.

On 15 December Campany "A", 3d Anti Tank Battalion was attached to this Battalion.

On 15 December tank B-22 nit a mine on the road from Camp Carroll to Dong Ha while proceeding to HAS Company forward for maintenance.

The location of the gun companies and their supported units were as follows:

The Battalion Reconnaissance Squad continued its activities around the Command Post. On 26 December the squad made contact which resulted in one VC KIA(C) and two VC KIA(P). There were no friendly casualties.

Defenses around the Battalion Command Post were improved by the installation of additional perimeter wire. Further improvements are planned.

A new Command Post defense order was published.

Two in-country orientation brieflags were held during the month with eighty-six newly joined personnel attending. On 12 December a class in Personal Response was conducted by personnel from the Division 3-5 section for members of H&S Company. On 11 December thirteen men of the Communications Section attended a class on communications records at the Division CP.

Two tink crowmin courses were conducted during the month for newly arrived 1811's.

The nightly briefings for all staff officer and section leaders continued.



LOGISTICS


On 31 Docomber 1967, this command had a shortage of 21 major end items; ten M46A3 tanks, one M51 recovery vehicle, four M38A1 utility trucks, one M37B1 truck, one M49C refueler truck, one TD-15 tractor, and three M5 mixing and transfer units. We major items of equipment were received during this period. The following items were evacuated: one M46A3 tanks, one lubrication and service unit, one TD-15 tractor, one M38A1 utility truck and 313 M14 rifles.

The 3d Plateen, Company "C" was redesignated as the 1st Plateen, Company "A", 5th Tank Battalian and "chopped" to BLT Tro-Four on 3 December 1967 as a part of the 9th MAB Special Landing Force. This plateen embarked on 29-30 December and contained the following personnel and major items of equipment: 1 officer and 26 enlisted, 5 M48A3 tanks, 1 M54 truck, 1 M38A1 utility truck, 1 M105A2 trailer, and 1 M100 trailer.

On 15 December 1967 Company "A" (Rein), 3d Anti-Tank Battalion was attached to the 3d Tank Battalion.

During this reporting period the primary supply activity has centored around the transfer of records and material from the 3d Anti-Tank Battalion for Company "A" (Rein) and the somiannual inventory. Shipment of miscollaneous parts and T/E items to the Company Headquarters at Kho Sanh is now underway. The supply office had to be physically expanded in order to handle the increased work load. The supply annex for tank repair parts at Dong Ha has contined to funtion satisfactorily and has resulted in reduced deadline time of tanks. The requirement to cancel documents over 90 days old has created an additional backlog of work. Many items proviously requisitioned will have to be re-ordered on a higher priority in view of the lost laad time. Response to priority 02 requisitions has shown a slight improvement, primarily due to filling of walk-through requisitions. However, increased message follow-up has been necessary for most other requisitions.

The functioning of this command's maintenance sections continues to be satisfactory considering the wide dispersion of subordinate units. At the end of this reporting period there were 8 tracked vehicles, 15 motor transport vehicles and 1 ordnance item deadlined. Of these, 6 tanks and 11 motor transport vehicles were at third echolon maintenance facilities. The availability of tank repair parts required to remove vehicles from first and second echelon deadline has shown a slight improvment during this period. However, the major and items required to remove vehicles from third echolen deadline are still not available and the third echelon deadline ratio has continued




to expand accordingly. Items which qualify for organizational Red Ball action have been nominated as well as items at third echelon maintenance facilities. Lack of major items in the maintenance float assets continues to be a problem. There has been no appreciable improvement in the repair of infrared equipment. Receipt of 24 new pairs of M18A1 binoculars has partially resolved the critical shortages. Eighteen Xenon searchlights have been nominated for Red Ball action. The availability of first and second echelon motor transport repair parts has shown a slight improvement. However, lack of availability of direct exchange (DX) type electrical repair parts continues to be a problem area. Eight M38A1 utility trucks were evacuated to Third Force Service Regiment for repairs. No code letters will be issued until final determination can be made by 3d FSR. This evacuation policy along with T/E deficiencies has resulted in acute shortage of M38A1 utility trucks.

Services have continued to be satisfactory. Installation of plumbing in the permanent showers has not been completed by MCB-3 due to a lack of materials. Work has commenced on the grease trap for the messhall. No date for commencement of construction can be determined for the lubrication rack and water tower. The most significant service problem area continues to be inadequate electrical power for this battalion's portion of the Gia Le contonement.

Expansion of the tank battalion's portion of the Gia Le Combat Base perimeter as well as improvement of company positions has continued. Bunker construction materials are critically short. Many additional man hours are required to locally fabricate and improvise materials for contruction purposes. An additional burden has been placed on the companies to procure materials for construction of bunkers at permanent Dyemarker positions. No provisions were made for bunkers for supporting arms personnel except artillery units. Bunkers have been prefabricated at Gia Le and Dong Ha and transported to forward positions.

The everall transportation situation has again been impaired due to a lack of motor vehicle operators. The wide dispersion of subordinate units, infrequency of convoys, and time required to make round trips has only compounded the situation. Roughrider convoys are the principle means used for resupply of the companies except the anti-tank company, which must be resupplied entirely by air. Transportation of individual personnel to deployed units remains unpredictable and in many instances requires several days due to the lack of air transportation during the meansoon season.



There were a total of three incidents of enemy mine and RPG damage during this period. One M48A3 tank USMC #201922 belonging to Company "B" hit an unknown type enemy mine on 12 December 1967. The suspension sytem was severly damaged. The damaged items were repaired or replaced and the vehicle has been restored to service. One My8A3 tank #202154 belonging to Company "B" was hit by an RPG rocket on 19 December 1967. The Commander's cupola, vision blocks and sponson box were damaged. Repairs have been completed and the vehicle is now operational. One M54 truck USMC #302421 belonging to Company "A" hit a mine on 17 December 1967. The vehicle is presently in a forward position awaiting evacuation to a third echelon maintenance facility for a limited technical inspection to determine if it can be repaired. The M43A3 tank, USMC #217819 belonging to Company "C" which was reported damaged by a mine during the last period was declared boyong repair and turned into salvage on 7 December 1967.

During the month, the Motor Transport Platoon and organic company vehicles logged 21,807 miles, hauled 1,314 short tens and transported 2,741 personnel.

There were seven personnel who required modical evacuation during December 1967.



CIVIL AFFAIRS

The battalion civil affairs officer attended the III MAF Civil Affairs Orientation Course from 29Nov67 through 10Dec67.

The battalion's CAAR, Loc Son Village at coord. (YD 934084), gained another hamlet during the month of December. On 18Dec67, the hamlet chief of Ha Ton asked permission from the Fhu Loc District Chief to move his hamlet into the Loc Son Village area. Permission was granted. As of 23Dec67, five homes in the new hamlets of Ha Chau and Ton that, were erected. There are 43 families in the Ha Ton Hamlet.

Construction of wells in the refugee hamlet of Ha Nam is well under way. The villagers have completed four, three foot tiles.

The battalion obtained 850 sheets of tin from CORPS for the purpose of roofing all homes in the hamlet of Ha Nam. The tin was delivered on 19Dec67.

Due to the mensoon, construction has been hampered. The villagers of Ha Nam expect to complete the roofing of their homes by 10Jan6d.

Two projects will go into the construction stage during the first week of Jan 68. The first is the village dispensary at coordinates (YD 933084). The second project is the contruction of a footbridge between the hamlets of Ha Nam and Ha Chau.

The battalion ModCap began on 26Dec67. The battalion corpsman lives with the CAC unit in the village. The CAC corpsman and the battalion corpsman conduct MedCaps each morning and afternoon.

Two members of the battalien attended the Third Marine Division Personal Response Course on 4Dec67, for a two day period.



PSYCHOLOGICAL OPERATIONS

The battalion's phychological operations during December were active in conjunction with the Christmas program conducted in the battalion's CAAR, Loc Son Village, Phu Loc District.

The media employed were the culture drama team from JUSPAO, the metion picture team from 244th Psy Ops Company, health leaflets and publications.



COMMUNICATIONS-ELECTRONICS

During December the Communications Platoon continued to improve communications systems within the battalion area. The communications center continued to pick up traffic from the Third Engineer Battalion, which holds communications and crypto guard for the Gia Le Base. During December a new system of handling outgoing radio traffic was instituted. All messages are now routed thru the message center prior to delivery to the radio section for transmission. The radio section reported no unusual incidents. Communications with both superior and subordinate units were maintained. The Tech shop reported that approximately 90% of the SL's and TM's ordered during September, were received during December.

A series of tests were conducted to determine if the M8 gas mask is compatable with the new CVC helmets. It was determined that the above mentioned pieces of equipment are not compatable. A solution, is to have the tankers wear the M17 gas mask, when using the new CVC helmet.



MEDICAL AND DENTAL

During the month of December 1967, 687 cases were seen at sick call. This continues to reflect an increase over previous months. No significant disease trends have been established although upper respiratory infections continue to be the largest percentage of cases treated. Three cases of amoebic dysentery have been diagnosed and treated during the past menth. The source of the outbroak has not been established at the present time. There were fifteen non-hostile injuries during the month of December. A total of 850 immunizations were given and all immunizations are current both in the battalion CP and in the Companies.

Voncreal disease has shown a sharp increase over the previous menth with a total of nine cases being reported. Five were in the battalion CP and four in the companies. Three cases contracted in-country and six out-of-country.

Routine dental care and prophylaxis continues to be readily available at the 3d Engineer Battalien.

Hospital Corps personnel have been slightly increased with the addition of one additional man to cover the increase of Marine personnel as a result of a merger of units. The present strength is considered adequate.

Sanitation of the battalion CP area and companies remains satisfactory due primarily to continued improvements and excellent cooperation from responsible battalion personnel on th correction of noted discrepancies.

The night evacuation of an emergency case revealed some problem areas. An evaluation of the system was made and corrective actions taken.

Training of Marine and Hospital Corps personnel continues with emphasis on First Aid, Sanitation, and indoctrination of new personnel regarding VD, proventive medicine and nercotics. Training of Hospital Corps personnel continues to emphasize technical subjects within their specialty.

Tests conducted to determine the compatibility of the gas mask and the new CVC helmet.

4 Dec 1967 Tanks of 1st Platoon Alpha Co. fired 10 cannister, 10 HE, and 7 WP outside perimeter at suspected enemy infiltration routes.

Tanks of 1st Platoon Alpha Co. fired 25 cannister, and 5 HE outside perimeter at probable enemy infiltration routes.

Tanks of Bravo Co. security for roughrider fired 1 cannister, 800 .30 cal at possible enemy ambush sit.s.

5 Dec 1967 The battalion S-5 delivered 35 bags of cement to the village of Loc Son. 5 bags of cement were for a pagoda at coordinates (YD 927051). 30 bags were for the contruction of two wells in the hamlet of Ha Nam. 1 blacksmith kit was also delivered to

the village blacksmith and 4 blackboards for the schools in the village.

6 Dec 1967 Tanks of Bravo Co. ran security for a convoy firing 1000 .30 cal recon by fire w/negative results.

H48A3 tank USMC #217819 declared a combat loss and turned into salvage.

7 Dec 1967 Inspected Co. "A" and Co. "B"

8 Dec 1967 Tanks of 2nd Platoon Charlie Co. went on patrol with A-1/9 a total of approximately 7000 meters in an area North West of 1/9 CP had negative contact. Patrol from 0730-1600, 7 Dec 1967.

Tanks of 1st Platoon Alpha Co. fired 5 HE direct and 10 cannister outside perimeter at known enemy infiltration routes w/negative results.

Tanks of 5th Platoon Alpha Co. fired a total of 20 HE at suspected enemy rocket positions to the West of their position indirect fire w/unknown results.

The Battalion S-5 mot the sub-sector advisor in the battalion CAAR to discuss projects.

10 Dec 1967 Tanks of 1st Platoon Alpha Co. fired 20 HE H&I direct and 5 cannister at enemy infiltration routes outside the perimeter with unknown/negative results.

The S-5 took the plans for the school in Ha Nam Hamlet to district headquarters. The plans were approved and materials will be supplied through the ARVN supply system.

Tanks of Bravo Co. on a run to Ca Lu security for roughrider fired 4 cannister, 1 WP, Flamo 60 sec rod, 4000 .30 cal recon by fire.

12 Dec 1967 Tanks of 3d Platoon Bravo Co. went on road patrol in support of 1/26, fired 10 HE at suspected enemy anti-aircraft position w/unknown results.

Tanks of 2d Platoon Bravo Co. fired 2500 .30 cal recon by fire on roughrider in support of 3/9.

B-22 Hit a mino on way to forward maintenance from Bravo CP while taking bridge by-pass. Hole 6' diameter and 4-5' deep. (USMC #201922)

The battalion S-5 went to the CORDS Refugee Office in Hue and explained the refugee situation in the battalion CAAR. There are actually two refugee hamlets, Ha Chau at coordinate (YD 935084) and Ha Nam at coordinate (YD 938083). The S-5 requested material assistance for the hamlet of Ha Nam; 850 sheets of tin. A tentative date to pick up the material from CORDS warehourse was set as 19Dec67.

The Third Marine Division Personal Response Contact Team gave a 45 minute class to H&S Company, Third Tank Battalion.

Tanks of 1st and 5th Platoons Alpha Cp. fired a total of 25 HE direct, 5 cannister at infiltration routes and suspected enemy concentrations w/nagative results.


The JUSPAO Culture Drama Team operated in the battalion's CAAR as part of the Christmas Program. They were there for a period of two days operating in the schools during the day and in the village square in the evening.

14 Dec 1967 Tanks of 1st Platoon Alpha Co. fired 25 HE, 15 cannister at enemy infiltration routes w/negative results. (direct fire)

Tanks of Bravo Co. security on run to Ca Lu roughridor fired 2000 .30 cal recon by fire w/negative results.

The battalion S-5 went to Phu Loc District Headquartors for a meeting with the District Chief and sub-sector advisor concerning refugees and the situation in Loc Son Village. Like CORDS they were not aware of the acutal situation with two separate hamlets.

The battalion \$-5, district chief, sub-sector advisor, Loc Son Village Chief and his village officials met in the afternoon. They went to the hamlets of Ha Chau and Ha Nam to actually see the situation as it was on the ground. All misunderstandings were cleared and location and names of the two refugee hamlets were recorded at district.

15 Dec 1967 A-33 fired a total of 32 HE indirect at enemy movement around perimeter. Results 5 KIA(C), 5 KIA(P).

- 1. Purpose. To provide instructions for the conduct of the defense of the 3d Tank Battalion Sector of the Gia Le Combat Base.
- 2. Cancellation. Battalion Order 5510.43, Battalion Order 3121.1

#### 3. Background

- (a) Reference (a) tasks this Battali n with the responsibility for the defense of Sector III of the Gia Le Combat Base. This sector encompasses the Battalion Command Post.
- (b) Proper defense of this Sector encompasses those measures necessary to defend the established perimeter and to deny the enemy access to and movement in areas adjacent to the perimeter.
- The tasks necessary for the defense Readiness Conditions. of the Battalion Comand Post can be related to the enemy threat. The threats and overall defensive measures are described in the following readiness conditions. Unit and individual responsibilities during these conditions as well as bunker, listoning post and tank slot locations are described in enclosure (1).

Bn0 5510.40 19 Dec 1967

- a. CONDITION IV This is the normal condition from 0630 to 1830 when there is no known enemy threat. During Condition IV all units will conduct normal operations. Bunker 2 and Listening Post Alpha will be manned and patrolling will be conducted as scheduled. Condition IV will be automatically set at 0630 unless the Base Defense Coordinator directs otherwise.
- b. COMDITION III This is the normal condition from 1830 to 0630 when there is no known enemy threat. During Condition III all units will conduct normal operations. Bunkers I through 7 will be manned by three men one of whom will be awake at all times. Listening Post Alpha will be manned by four men two of whom will be awake and alert at all times, and the assigned tank will be stationed at tank slot I with one crewman awake and alert at all times. The entire perimeter will be under constant observation from the bunkers and patrols will be conducted as scheduled. The Base Defense Net will be entered at 1830. Condition III will be set automatically at 1830, unless the Base Defense Coordinator directs otherwise.
- c. CONDITION II This is a modification of Condition III assumed on order of the Base Defense Coordinator when it is suspected or known that the enemy will attack or attempt infiltration in from three to seventy-two hours. During this condition bunkers I through 7 and Listening Post Alpha will each be manned by four men two of whom will be awake at all times, and the assigned tank will be at tank slot I with the crew on 50% alert. Further, the Reaction Squad will be on alert. The Battalion Reconnaissance Patrol will continue its activity based on available intelligence. If the Base Defense Net has not been entered such will be accomplished immediately upon the setting of this condition. The order to set Condition II will be passed verbally.
- d. CONDITION I This is the highest state of alert and is assumed on order of the Base Defense Coordinator when it is known or suspected that the enemy will attack or attempt infiltration in from one to one hundred and eighty minutes. During this condition bunkers I through 7 and Listening Post Alpha will each be manned by four men and all will be awake and alert at all times, also the tank assigned will be at tank slot I with the crew on 100% alert. Further, all personnel will man their fighting positions, the Reaction Squad will muster in the trench adjacent to the COC bunker, supplementary ammunition will be issued and if not already accomplished the Base Defense Net will be entered. The Battalion Reconnaissance Patrol will conduct activities based upon available intelligence. The signal to set Condition I will be a steady siren for two minutes.

- e. CONDITION ALPHA Condition Alpha will be set when a mortar, artillery, rocket or air attack is occurring or is immonent. During this condition only passive defense measures are instituted, however Condition I may follow. All personnel will take the nearest available cover immediately and be prepared to set Condition I. Additionally, if not previously accomplished the Base Defense Net will be entered. The signal to set Condition Alpha will be a steady two minite blast on a horn located in the Third Engineer Battalion Area.
- 5. Arms and Equipment. Personnel manning bunkers and listening posts durin; all readiness conditions and all personnel during Condition I will have the following arms and equipment.
  - T/O weapons with a basic load of ammunition
  - b. Body Armor (flak jacket) (except personnel manning tanks)
  - c. Holmets
- d. Cartridge or pistol belt with jungle kit and filled cantoen
  - e. Field Protoctive Mask
  - f. Foul weather clothing as required

#### Responsibilities 6.

## (a) Battalion S-3

- (1) Coordinate with the Base Defense Coordinator on matters of mutual interest to this and other sectors.
- (2) Plan and control all patrol, amoush and listening post activities in the Battalion Sector.
- (3) Organize and train the Battalion Reconnaissance The composition and duties of this squad are set forth in enclosure (8).
- (4) Propare and maintain current, a schematic of the sector perimeter defenses including bunkers, defensive wires, fighting holes and trenches; location of Seismic Intrusion Devices, (SID) AN/PSR-1 and Claymore Mines. One copy of this schematic will po provided to the Gia Le Baso Defense Coordinator.

## (b) Headquarters Commandant

- (1) Organize and supervise the Battalion perimeter defense in accordance with enclosure (2).
- (2) Ensure that all hands to employ them are trained in the operation of the Seismic Intrusion Devise, AN/PSR-1, the Claymore Mine, 118A1, the .30 caliber and .50 caliber and M60 machine guns, M79 Grenade Launcher, M16Al Rifle and T/O weapons.

- (3) Promulgate a daily watch bill assigning personnel to man bunkers I through 7 at 1830 during Condition III, LP Alpha under all readiness conditions, the Reaction Squad and Line MCO.
- (4) Publish Orders for the Line MCO's and Bunker, Tank Slot and Listenin; Post watch standers.

#### (c) Communications Officer

(1) Supervise the maintenance of wire communications throughout the Battalion perimeter, to other sectors within the Gia Le Combat Base and to higher and adjacent headquarters. The 3-3 will be notified when wire communication to any station is out and when it is restored.

#### (d) Battalion S-1

- (1) Advise all transient personnel of their responsibilities during Condition I, II and Alpha.
- (2) Promuleate watch bills for the GOC Watch Officer, Commander of the Guard and Sergoant of the Guard.
- (e) Platoon Commanders. Platoon Commanders will be responsible to the Headquarters Commandant for the maintenance of the secondary line positions in their respective areas.
- (f) COC Watch Officer. The duties of the COC Watch Officer are set forth in enclosure (3).
- (g) Commander of the Guard. The duties of the Commander of the guard are set forth in enclosure (4).
- (h) Sorgeant of the Guard. The duties of the Sergeant of the Guard are set forth in enclosure (5).
- 7. Pyrotechnic Signals. The following pyrotechnic signals shall be used for the purpose indicated only.
  - a. Green star cluster Meaning friendly troops
  - b. Rod star cluster Meaning onemy contact
- 8. Rules of Engagement. The rules of engagement set forth herein are designed to minimize casualties among friendly and non-combatant personnel. However, nothing stated in this paragraph is intended to infringe on the inherent right of the individual to defend himself and his unit from attack. In the event of attack the individual concerned may take immediate aggressive action against the attacking force by any means available. Because of the difficulties in recognition during darkness the following procedures will be followed during the hours of darkness.

- 9. Weapons Safety. All personnel will strictly adhere to the provisions of reference (b) in the execution of this order.
- 10. Drills. Periodically drill alerts will be conducted. During such drills all the provisions of this order will be complied with.

#### RESPONSIBILITES DURING ALERT CONDITIONS

- 1. The perimeter defense will be constructed as shown in Appendix A. It will consist of seven bunkers, one listening post and one tank position in the primary line of defense and fighting holes, bunkers and trenches in the supplementary line of defense. The Reaction Squad will be the reserve. Its organization and duties are set forth in enclosure (6).
- 2. For purpose of this order the Communications Section and Headquarters Section of H&S Company are designated the Communications Platoon and Headquarters Platoon. The Communications Officer is assigned as Communication Platoon Commander and the Battalian S-3 Officer is designated as the Headquarters Platoon Commander. The Communication Platoon will be composed of the personnel from the Battalian Communication Section. The personnel of the S-1, S-2, S-3 and S-4 Sections, the mail orderly, the Commanding Officer's driver and the Battalian Career Advisory NCO.
- 3. desponsibilities during the various conditions are listed below:

#### a. Headquarters Commandant

- (1) Assign personnel to man bunker 1-7 during Condition III.
- (2) Assign personnel to man Listening Post Alpha under all readiness conditions.
- (3) Assign one tank to be positioned in Tank Slot 1 during Condition I, II and III.
- (4) Assign four cocks/messmen to report to the Bettalion Aid Station for duty as stretcher bearers during Condition I.
- (5) As available, assign tanks to the reaction force on a daily basis.
- (6) During Condition I assume a mobile post in a tank in the perimeter area. Initially this post should be in the vicinity of bunker 10.
- (7) Ensure that the required materials listed in enclosure (2) are available at bunkers 1 through 7, tank slot 1, and Listening Post Alpha.

#### b. Communications Platoon Commander

- (1) Assign personnel to man bunker 1 upon the setting of Londition I or 17 at any time between 0630 and 1030.
- of Mondition I or II at any time between 0630 and 1030.



#### DUTIES OF THE COMMAIDER OF THE GUARD

Like Cords, They had the hamlet of Ha Chau located some 500-600 meters north of its actual location and under another name. It seems that when the people of Ha Chau were scheduled to move the site for their relocation was near the hamlet of Ton Khat at the coordinates YD936058. As it turned out this area was under six to eight feet of water and so the people went to their present position. Cords aid not change their map location or the name.

No one was aware of the situation with the hamlet of Ha Nam. District was under the impression that Ha Nam and Ha Chau were one in the same.

The battalion S-5, district chief and sub-sector advisor met at Loc Son Village at 1300 to see the situation as it actually was on the ground. They met with the village chief, Ha Nam Hamlet Chief, Ha Chau Hamlet Chief and two members of the village counsel.

It was settled that there are two refugee hamlets and that their names and locations are as reported by the battalions S-5.


